### **OLD BUSINESS:**

- 1. **Dollar General:** Village officials have been communicating with Dollar General on bringing their retention pond up to code.
- 2. **Center Street:** Shaw Construction is expected to return in the spring to finish the Center Street project landscaping. There is presently a drainage issue on Center near Church Street due to the grade.
- 3. A manhole drain cover in the parking lot east of M-15 south of Main Street needs repair.

#### **NEW BUSINESS:**

- 1. **Police Update:** The Village's new police officer, Jason Oliver, has been getting acquainted with the community. Police Chief Steve Roggentine will be retired as of Dec. 31, 2016.
- 2. **Roadwork:** M-DOT will be paving two driving lines on M-15 in the village next spring or summer. The village has applied for a scrap tire grant from the State of Michigan to help with the cost of paving the parking lane on the west side of M-15 at the same time and possibly Beckwith Street.
- 3. **Water Main Breaks:** While firemen were fighting a fire on Dean Drive this morning (Dec. 20), there were five water main breaks including one on Gleason Street and two on East Center Street. Shaw Construction was able to respond quickly to help the Village DPW with water main repairs.
- 4. **Vandalism:** Dugouts on the school yard were sprayed illegally.
- 5. **Master Plan:** The planning commission will start a five-year review of the village's master plan next year.
