ZONING ADMINISTRATOR'S REPORT:

- 1. Paperwork has been picked up for a party interested in applying for a demolition permit for a Bishop Street address. DPW Supt. Garth Ratza will be inspecting the utility caps before any back-filling is done.
- 2. Letters will be going out to a number of businesses regarding their obsolete signs, as per the sign ordinance.

3. Discussion on vacant buildings in town, parking problems, apartment building upkeep.

4. There is no agricultural-zoned property in the village. Livestock is not allowed in the village. Zoning permit was equired for a "barn" due to the zoning of the property.

OLD BUSINESS:

1. Master Plan: Jody Dean to follow up with Steve Erickson of the Economic Development Corp.

2. Master Plan Survey: Need to follow up on results of the survey with recommendations for the council. Sidewalk replacement is ongoing; related discussion on survey results. Recommendations were made to be included in the 2018 Annual Report.

It was noted the planning commission had not been given the snowmobile ordinance to review before being adopted by the council.

3. The school district is working on a proposal for a (sinking fund) millage, possibly 3 mills for 10 years. The old part of the Kirk School might be torn down, and grades K-5 or K-6 might be moved into the Meachum building.

4. Capital Improvement Program to be reviewed at the Commission's February meeting.

5. Proposed By-laws amendment postponed until the Commission's February meeting.
