Arbela Township Letter –** The council discussed the letter received from Arbela Township removing them from the inter-local agreement and stated that Arbela did not pay the full amount required for 2015. A new inter-local agreement needs to be completed between the Village of Millington and Millington Township.
- **5. Lawyers**: Mr. Reinert discussed the lawyer situation and will proceed with some reference calls on a few attorneys.
- **6. Center St. Project Update:** Mr. Ratza discussed the bids. The lowest bid received was 1.5 million. The construction on M15 took all the bids over budget. Mr. Ratza discussed the complications with the M-15 road section. Plans are being reviewed.

- **7. Tuscola County Recycling:** Mr. Reinert discussed that we are in the top 3 in the county for recycling. Tuscola County will be placing a trailer in the Township lot every Monday, starting October 26th, 2015 for residents to drop off their recycling as part of a pilot program.
- 8. **Medicare:** Sharon's current Medicare plan will expire December 31, 2015. Steve Paige will be looking into other options.
