### Call to Order:

The meeting was called to order by President Reinert in the Village Council Chambers at 6:00 p.m.

All recited the Pledge of Allegiance.

### Accept the Minutes

Fackler moved, Cobb seconded, PASSED the motion to accept the minutes as printed for the *November 9, 2015 Regular Council Meeting.* **6 yeas, 0 nays, 0 abstain.** 

Bassett moved, Maxfield seconded, PASSED the motion to accept the minutes as printed for the *November 23, 2015 Public Hearing.* **6 yeas, 0 nays, 0 abstain.** 

Fackler moved, Maxfield seconded, PASSED the motion to accept the minutes as printed for the *November 23, 2015 Special Council Meeting* with the correction of #3 Medicare Insurance by removing the "one-time" wording. **6 yeas, 0 nays, 0 abstain.** 

### **Department Reports:**

**Public Works:** *Mr. Ratza reported that everything was good and they were able to catch up on some small projects. He asked the council about getting new tires for the 4x4 pickup. Mr. Ratza has passed his first exam.*

Maxfield moved Cobb seconded PASSED the motion to allow Mr. Ratza to purchase tires for the 4x4 truck not to exceed \$800.

Mr. Bassett also reported that at the Planning Commission meeting, they denied Mr. Jorgensen a recycling center but are allowing the recycling of motors which will be strictly indoors. The Planning Commission gave him strict guidelines to follow. The parking of semi-trucks was discussed. Letters regarding the retention pond at Dollar General have also been sent.

- *3. Center St. Project: Mr. Shellenbarger discussed the Center Street project and the* 1947 water lines. Different options were discussed. Mr. Shellenbarger will contact Wanda Dzwira from the USDA about the interest rate.

**2.** Roth Electrical – Pump House VFD Replacement: *Mr. Ratza discussed the VFD getting a short in it. This unit will cost* \$14,990.00 to replace without the bypass. A bypass may be added later.

Fackler moved Cobb seconded *PASSED* the motion to purchase a new VFD Replacement for \$14,990.00.
