**1. First Net – AT&T Jeff & Chad**

Jeff Amley presented a presentation to the council about First Net cell phones. This will be looked into further.

**2. School Radio Repeater**

Nesbitt moved Bassett seconded **PASSED** the motion to allow Millington Community Schools to put a radio repeater on the water tower providing it does not interfere with the Thumb Cellular and T-Mobile signals at a cost of \$100 per year. **5 years 0 nays 0 abstain**

**3. Martha Swartz – parking on Main St overnight**

The Village has adopted the Michigan Vehicle Code Public Act 300 of 1949, section 257.606 of the MVC states that the municipality may place signs regulating overnight parking on 3x4 signs that are legible to any ordinarily observant person at the corporate limits of the municipality. The fine for parking overnight is \$25.00 which is listed in our ordinances Chapter 32-48.

**5. MML Liability Insurance**
