Call to Order:

The meeting was called to order by President Reinert in the Village Council Chambers at 6:00 p.m.

Accept the Minutes

Public Works: *Mr. Ratza reported that they had been busy. There was an issue with the lift station and he had Kennedy come out and adjust the settings on the VFD. Kennedy will be back to do a full checkup on the system. Mr. Ratza reported that Chevy is not making the pickup that was ordered, he could go to a ¾ ton for \$11,000 more but decided against it. They will make do with the current truck. Mr. Ratza discussed the scheduling of the water tower maintenance and painting. He will try to find a pressure tank.*

Police Department: *Chief Oliver reported that average calls were up from last year. The E-printer is working good and Officer Cartner is putting it to good use. He reported that they are doing more fingerprint cards. They are also waiting on Pro-Comm for the vehicle equipment swap. He will start enforcing the ordinance for junk vehicles in yards.
